REGULATION

TO AMEND THE ORISSA SCHEDULED AREAS TRANSFER OF IMMOVABLE  
PROPERTY (BY SCHEDULED TRIBES) REGULATION, 1956

WHEREAS it is expedient to amend the Orissa Scheduled Areas  
Transfer of Immovable Property (By Scheduled Tribes) Regulation,  
1956 ;

NOW, THEREFORE, in exercise of the powers conferred by  
sub-paragraph (2) of paragraph 5 of the Fifth Schedule to the  
Constitution of India, the Governor of Orissa is pleased to promulgate  
the following Regulation made by him in the Thirtieth Year of the  
Republic of India :—

Short title

1. This Regulation may be called the Orissa Scheduled Areas  
Transfer of Immovable Property (By Scheduled Tribes) Amendment  
Regulation, 1979.

Amendment  
of section 2.

2. In section 2 of the Orissa Scheduled Areas Transfer of Immo-<sup>Orissa</sup>  
vable Property (By Scheduled Tribes) Regulation, 1956 (hereinafter <sup>Regulation 2</sup>  
referred to as the principal Regulation), for clause (e), the following <sup>of 1956.</sup>  
clause shall be substituted, namely :—

“(e) “Scheduled Areas” and “Scheduled Tribes” shall, respecti-  
vely, mean the Scheduled Areas specified in respect of the State of  
Orissa in the Scheduled Areas ( States of Bihar, Gujarat, Madhya  
Pradesh and Orissa ) Order, 1977 and the ‘Scheduled Tribes’ specified  
in respect of the State of Orissa in the Constitution (Scheduled Tribes)  
Order, 1950 as modified from time to time;”

Amendment  
of section  
7-D.

3. In section 7-D of the principal Regulation for the words,  
brackets, figures and comma “the Constitution (Scheduled Tribes)  
Order, 1950”, the words, brackets, figures and comma “ the Constitu-  
tion ( Scheduled Tribes) Order, 1950 as modified from time to time”  
shall be substituted.

Repeal of  
certain  
provisions  
of the Land  
Reforms  
Act.

4. The provisions contained in the Orissa Land Reforms Act, 1960  
in so far as they relate to matters provided for in the principal  
Regulation shall, to the extent they are applicable to any of the  
Scheduled Areas within the meaning of the said Regulation as amended  
by this Regulation, stand repealed.
