ORISSA ACT 17 OF 1969  
**SHRI JAGANNATH TEMPLE LAWS  
 (AMENDMENT) ACT, 1969**

AN ACT TO AMEND SHRI JAGANNATH TEMPLE ACT, 1954 AND  
 SHRI JAGANNATH TEMPLE (AMENDMENT) ACT, 1968

**Be** it enacted by the Legislature of the State of Orissa in the Twentieth Year of the Republic of India, as follows :—

**Short title** 1. This Act may be called Shri Jagannath Temple Laws (Amendment) Act, 1969.

**Amendment of section 6, Orissa Act 11 of 1955.** 2. In section 6 of Shri Jagannath Temple Act, 1954 in **Orissa Act 11 of 1955.** sub-section (1)—

(a) for the words “consist of eleven members” the words “consist of twelve members” shall be substituted ;

(b) for clause (e) the following clause shall be substituted, namely :—

“(e) four persons to be nominated by the State Government from among the Sevaks of the Temple.....Members;”;

(c) clause (f) shall be omitted ;

(d) for clause (h) the following clause shall be substituted, namely :—

“(h) two persons to be nominated by the State Government from among persons who do not belong to any of the categories referred to in clauses (e) and (g)....Members.”

**Amendment of section 18, Orissa Act 17 of 1968.** 3. In section 18 of Shri Jagannath Temple (Amendment) Act, **Orissa Act 17 of 1968.** 1968—

(a) for the words “on the expiry of a period of three months” the words “on the expiry of a period of one year” shall be and shall be deemed always to have been substituted;

(b) in the proviso for the words “as amended by this Act” the words and figures “as amended by Shri Jagannath Temple Laws (Amendment) Act, 1969” shall be substituted;

(c) after the existing proviso the following new proviso shall be added, namely :—

“Provided further that if at any time prior to the expiry of the period of one year or, as the case may be, the extended period as aforesaid, the Committee is reconstituted in accordance with the principal Act as amended by Shri Jagannath Temple Laws (Amendment) Act, 1969, the said members shall cease to hold office with effect from the date of notification of the appointment or nomination of the members of the Committee as so reconstituted.”

Repeal and  
reviving.

4. (1) Shri Jagannath Temple (Amendment) (Amendment) Orissa  
Ordinance, 1969 is hereby repealed. Ordinance  
2 of 1969.

(2) Notwithstanding such repeal anything done or any action taken under the said Ordinance shall be deemed to have been done or taken under this Act as if this Act were in force on the day on which such thing was done or such action was taken.
