**ORDINANCE**

TO AMEND THE ORISSA ESSENTIAL ARTICLES CONTROL  
 AND REQUISITIONING (TEMPORARY POWERS)  
 ACT, 1950

**WHEREAS** the Legislature of the State of Orissa  
 is not in session ;

**AND WHEREAS** the Governor of Orissa is  
 satisfied that circumstances exist which render it  
 necessary for him to take immediate action to amend  
 the Orissa Essential Articles Control and Requisi-  
 tioning (Temporary Powers) Act, 1950 in the manner  
 hereinafter appearing ; Orissa Act  
XII of 1951.

**AND WHEREAS** the instructions from the Presi-  
 dent have been received to promulgate such an  
 Ordinance ;

**NOW, THEREFORE**, in exercise of the powers  
 conferred by clause (1) of Article 213 of the  
 Constitution, the Governor of Orissa is pleased to  
 make and promulgate the following Ordinance :—

Short title  
and com-

**1.** (1) This Ordinance may be called the Orissa  
 Essential Articles Control and Requisitioning  
 (Temporary Powers) (Amendment) Ordinance, 1955.

(2) It shall come into force on the 26th day of  
 January 1955.

**2.** In sub-section (4) of section 1 of the Orissa  
 Essential Articles Control and Requisitioning (Tem-  
 porary Powers) Act, 1950 (hereinafter referred to as  
 the said Act), for the words, letters and figures  
 "26th day of January 1955" the words, letters and  
 figures "26th day of January 1957" shall be substi-  
 tuted. Orissa Act

3. To section 18 of the said Act the following new sub-section shall be added, namely :—

“(3) Notwithstanding anything contained in any of the provisions of this Act, any order made by the Central Government or the State Government as the case may be, under the provisions of the Essential Supplies (Temporary Powers) Act, 1946 in respect of any of the essential articles specified in item 1 of the schedule to this Act, and in force immediately before the 26th day of January 1955 shall be deemed to be an order made by the State Government under this Act and shall continue in force accordingly ; and all appointments made, licences or permits granted, directions issued and things done under any such order or the Act herein specified, as the case may be and in force immediately before the said date shall likewise continue in force and be deemed to be made, granted, issued or done in pursuance of this Act.”

4. For the existing Schedule to the said Act, the following new Schedule shall be substituted, as namely :—

#### THE SCHEDULE

(i) Foodgrains, namely :—

- (a) Wheat
- (b) Paddy (rice in husk)
- (c) Rice (husked)
- (d) Jawar
- (e) Bajra
- (f) Maize
- (g) Barley
- (h) Minor Millets, e.g., Ragi, Kodo
- (i) Gram

(ii) Manures

(iii) Kendu leaves

(iv) Horns and bones

(v) Patal Garud

(vi) Hides and skins
