AN ACT TO AMEND THE ORISSA TOWN PLANNING AND  
IMPROVEMENT TRUST ACT, 1956

**BE** it enacted by the Legislature of the State of Orissa in the  
Twenty-sixth Year of the Republic of India as follows:—

**Short title** 1. This Act may be called the Orissa Town Planning and  
Improvement Trust (Amendment) Act, 1957.

2. Section 8 of the Orissa Town Planning and Improvement Trust  
Act, 1956 (hereinafter referred to as the principal Act) shall be re-  
numbered as sub-section (1) thereof and—

(a) in sub-section (1) as so renumbered, in clause (f), for the  
word “four”, the word “six” shall be substituted;

(b) after the said sub-section (1), the following new sub-section  
shall be inserted, namely:—

“(2) The State Government shall appoint one of the trustees to  
be the Vice-Chairman of the Trust who shall exercise the powers and  
perform the functions of the Chairman during his absence.”.

3. For section 12 of the principal Act, the following section shall  
be substituted, namely:—

Condition of  
service of  
Chairman,  
Vice-Chair-  
man and  
Trustees.

“12. The conditions of service of the Chairman, Vice-Chairman  
and the Trustees shall be such as may be prescribed from time to  
time.”.

Substitution  
of section 13,  
Orissa Act  
10 of 1957.

4. For section 13 of the principal Act, the following section shall  
be substituted, namely:—

Trustees, etc.  
shall hold  
office during  
the pleasure  
of the  
Government.

“13. The Chairman, Vice-Chairman and the Trustees, other than  
*ex-officio* Trustees, shall hold office during the pleasure of the State  
Government.”.
