## THE ODISHA APPROPRIATION (No.2) ACT, 2017

**AN ACT TO PROVIDE FOR THE AUTHORISATION OF APPROPRIATION OF MONEYS OUT OF THE CONSOLIDATED FUND OF THE STATE OF ODISHA TO MEET THE AMOUNTS SPENT ON CERTAIN SERVICES DURING FINANCIAL YEARS ENDING ON THE 31ST DAY OF MARCH OF THE YEARS 2011 TO 2012 IN EXCESS OF THE AMOUNTS GRANTED FOR THOSE SERVICES AND FOR THOSE YEARS.**

**Be it enacted by the Legislature of the State of Odisha in the Sixty-eighth Year of the Republic of India as follows :—**

| Appropriation.  | 3. The sums deemed to have been authorised to be paid and applied from and out of the Consolidated Fund of the State of Odisha under this Act shall be deemed to have been appropriated for the services and purposes expressed in the Schedule in relation to each financial year which ended on the 31st day of March of the years 2011 to 2012.   |
