

## THE UTKAL UNIVERSITY (AMENDMENT) ACT, 1949.

[Received the assent of the Governor on the 26th April 1949, first published in an extraordinary issue of the Orissa Gazette dated the 30th April 1949]

## AN ACT FURTHER TO AMEND THE UTKAL UNIVERSITY ACT, 1943.

WHEREAS it is expedient further to amend the Utkal University Act, 1943, in the manner hereinafter appearing; Orissa Act XIII of 1943.

It is hereby enacted as follows :—

Short title.

1. This Act may be called the Utkal University (Amendment) Act, 1949.\*

Amendment of section 7, Orissa Act XIII of 1943

2. In section 7 of the Utkal University Act, 1943 (hereinafter referred to as the said Act)—

(i) in sub-section (1) the words “ on the expiration of which period he may be reappointed from time to time” and the first proviso shall be omitted and for the proviso immediately appearing thereafter the following proviso shall be substituted, namely :—

“ Provided that the Chancellor may in his discretion reappoint the Vice-Chancellor from time to time for a total period not exceeding six months from the date of expiry of his appointment without calling upon the Senate to recommend a panel of three persons. ”;

(ii) to sub-section (1) the following explanation shall be added, namely :—

“ *Explanation*—Nothing in the sub-section shall debar the Senate to include in the panel of three persons recommended by it the name of any Vice-Chancellor after the expiration of his period of appointment hereinbefore specified.”

Amendment of section 8, Orissa Act XIII of 1943.

3. In section 8 of the said Act—

(i) in paragraph (i) under clause (b) with the heading “ Fellows for life ” of sub-section (1), for the word “ two ” the word “ five ” shall be substituted ;

(ii) in sub-section (3) after the second proviso to paragraph (iv) under the heading “ Class I—Elected Fellows ” the following explanation shall be inserted, namely :—

“ *Explanation*—The expression registered graduates hereinbefore appearing shall mean such registered graduates as are not included for the time being in the electorate of registered teachers of colleges or registered graduate teachers of schools.”

Amendment of section 9, Orissa Act XIII of 1943

4. In clause (a) of sub-section (3) of section 9 of the said Act—

(a) in sub-clause (i) for the word "three" the word "two" shall be substituted ;

(b) after sub-clause (i) the following sub-clause shall be inserted, namely :—

"(ii) one shall be a registered graduate teacher of a school elected under the provisions of paragraph (2) under the heading 'Class I—Elected Fellows' of sub-section (3) of section 8 ;"

(c) the existing sub-clause (ii) shall be renumbered as sub-clause (iii).

Amendment of section 10, Orissa Act XIII of 1943.

5. In sub-section (2) of section 10 of the said Act—

(i) for the words "eleven teachers of colleges" the words "ten teachers of colleges and one registered graduate teacher of schools" shall be substituted ;

(ii) after the word "colleges" the words "and schools" shall be inserted.
