**AN ACT TO PROVIDE FOR THE AUTHORISATION OF APPROPRIATION OF MONEY
OUT OF THE CONSOLIDATED FUND OF THE STATE OF ORISSA TO
MEET THE AMOUNTS SPENT ON CERTAIN SERVICES DURING
THE FINANCIAL YEAR ENDED ON THE 31ST DAY OF
MARCH, 1965 IN EXCESS OF THE AMOUNTS
GRANTED FOR THOSE SERVICES
AND FOR THAT YEAR**

BE it enacted by the Legislature of the State of Orissa in the
Twenty-first Year of the Republic of India as follows :—

Short title

1. This Act may be called the Orissa Appropriation (No. 3)
Act, 1970.

2. From and out of the Consolidated Fund of the State of Orissa, the sums specified in column (3) of the Schedule amounting in the aggregate to the sum of rupees three crores, two lakhs, twenty-four thousand, six hundred and twelve shall be deemed to have been authorised to be paid and applied to meet the amount spent for defraying the charges in respect of the services specified in column (2) of the Schedule during the financial year ended on the 31st day of March 1965, in excess of the amounts granted for those services and for that year.

Appropriation.

3. The sums deemed to have been authorised to be paid and applied from and out of the Consolidated Fund of the State of Orissa under this Act shall be deemed to have been appropriated for the services and purposes expressed in the Schedule in relation to the financial year ended on the 31st day of March, 1965:
