# \*THE ORISSA MUNICIPAL COUNCILS (REDUCTION OF TERM OF OFFICE) ACT, 1977

[Received the assent of the Governor on the 13th October 1977, first published in an extraordinary issue of the Orissa Gazette, dated the 14th October 1977]

AN ACT TO PROVIDE FOR THE REDUCTION OF THE TERM OF OFFICE OF CERTAIN MUN CIPAL COUNCILS AND NOTIFIED AREA COUNCIL OF THE STATE AND FOR MATTERS INCIDENTAL THERETO

B<sub>E</sub> it enacted by the Legislature of the State of Orissa in the Twenty-eighth Year of the Republic of India, as follows:—

Short title, extent and commencement.

- 1. (1) This Act may be called the Orissa Municipal Councils (Reduction of term of Office) Act, 1977.
  - (2) It shall extend to the whole of the State of Orissa.
  - (3) It shall be deemed to have come into force on the 22nd August, 1977.

**Definitions** 

- 2. In this Act, under the context otherwise requires,—
  - (a) "Municipal Act" means the Orissa Municipal Act, 1950;

Orissa Act 23 of 1950.

- (b) "Municipal Council" means a Municipal Council costituted under the Municipal Act and shall include a Notilfied Area Council costituted thereunder;
- (c) words and expressions used in this Act, but not defined herein, shall have the same meaning as assigned to them respectively, under the Municipal Act.

Reduction of term of office.

- 3. Notwithstanding anything contained in the Municipal Act, the State Government may, by notification, direct that the term of office of the councillors of all the Municipal Councils of the State as extended by the direction issued by the State Government under sub-section (6) of section 41 of the Municipal Act and published with the notification of the State Government in the Urban Development Department No. S. R. O. 319, dated the 17th May 1977, be reduced by such period as they deem fit.
- Consequences of Municipal Councils by a direction issued under section 3,—
  term of office.
  - (a) the provisions contained in sub-section (4) of section 41 of the Municipal Act shall apply to the said Municipal Councils, with effect from the date of expiry of the term of office of the councillors thereof;

- (b) the election or nomination, as the case may be, of the councillors for reconstitution of the said Municipal Councils shall be held in accordance with the provisions of the Municipal Act on such date within a period of four months from the date of expiry of the term of office of the councillors, as may be directed by the State Government; and
- (c) the Municipal Councils so reconstituted, shall, for all purposes, be deemed to have been constituted under and be governed by the provisions of the Municipal Act and the Rules made thereunder.

Repeal

- 5. (1) The Orissa Municipal Councils (Reduction of Term of Office Orissa Ordinance, 1977, is hereby repealed.

  Ordinance, 1977, is hereby repealed.
- (2) Notwithstanding such repeal, anything done or any action taken (including any direction issued) under the said Ordinance, shall be deemed to have been done or taken under this Act.
