t. This Act may be called the Orissa Grama Panchayars (Amandment)

2. In section 13 of the Orissa Grama Panchayats Act. 1966 (hereinafter Johns Act 1985).

- (i) in the marginal heading of section 13, after the word "election" the comma and words, "detection in certain cases" shall be inserted, and
- (ii) section 13 shall be renumbered as sub-section (1) thereof and, after sub-section (1) as so renumbered, the following sub-section shall be inserted, namely:—
- reserved under section 10 for any particular category and the Sub-Collector fails to nominate under sub-section (1) a person to such office or seat, as the case may be for non-availability of an eligible person belonging to that category, such office or seat shall, on recommendation being made to that effect by the Sub-Collector, be desceived by the Collector after such entries as he may deem fit and shall, thereafter, be filled up by fresh election.
- 3. In section 108 of the principal Act, for the word "Collector", the words and commes "the Disease Collector, the District Panchayat Officer appointed by the State Government" shall be substituted.
- A in section 110 of the principal Act in sub-section (1), for the words authorised by the Collector, the words and commas Director, Collector, District Panehayat Officer appainted by the State Covernment by such other officer of parton authorised under the said section of authorised by the Director authorised by the Director authorised by the Director of State Covernment of State Cov
- 5. In section 111 of the principal Act, in sub-section (1), for the word "Collector," wherever it occurs, the words and commas "Director, Collector, District Panchayar Officer" shall be substituted.
- 6. In the principal Act, for the word "Munsif" wherever it occurs, the words and brackets "Civil Judge (Junior Division)" shall be substituted.

AN ACT FURTHER TO AMEND THE ORISSA ADVOCATES' WELFARE FUND ACT, 1987.

Be it enacted by the Legislature of the State of Orissa in the Fiftysecond Year of the Republic of India as follows:

Short title

1. This Act may be called the Orissa Advocates' Welfare Fund (Amendament) Act, 2001.

Amendment of Section 15.

2. In the Orissa Advocates' Welfare Fund Act, 1987 (hereinafter referred to as the principal Act), in section 15—

- (i) in sub-section (3), for the words "one hundred", the words "Two hundred" and for the word "fifty" appearing in the proviso thereto, the words "one hundred" shall be substituted, and
- (ii) in sub-section (5), for the words "Nil", "fifty rupees" and "one hundred rupees" appearing against clause (a), clause (b) and clause(c) thereof, the words "fifty rupees", "one hundred rupees" and "two hundred rupees" shall, respectively be substituted.
