ORISSA ACT 4 OF 1989

***THE ORISSA FOREST PRODUCE (CONTROL OF TRADE)
(AMENDMENT) ACT, 1989**

[Received the assent of the President on the 1st April 1989, first published in an extraordinary issue of the *Orissa Gazette*, dated the 3rd April 1989]

AN ACT TO AMEND THE ORISSA FOREST PRODUCE (CONTROL OF TRADE) ACT, 1981

BE it enacted by the Legislature of the State of Orissa in the Fortieth Year of the Republic of India, as follows :—

Short title
and
commence-
ment.

1. (1) This Act may be called the Orissa Forest Produce (Control of Trade) (Amendment) Act, 1989.

(2) It shall be deemed to have come in to force on the date on which the Orissa Forest Produce (Control of Trade) Act, 1981 (hereinafter referred to as the principal Act) had come in to force, i. e., 5-9-1981 when the Principal Act was notified in the *Orissa Gazette*. Orissa Act

2. In section 5 of the principal Act, for sub-section (1) excluding clause (b) and the explanations thereunder, the following shall be substituted, namely :—

“(1) Notwithstanding any provision to the contrary in any other law, on the issue of a Notification under sub-section (3) of section 1 in respect of any area,—

(a) all contracts for the purchase, sale, gathering or collection of specified forest produce grown or found in the said area and all grants of profit-a-prendre including the right to enter upon the land, fell, cut and remove the specified forest produce from the said area, shall stand rescinded, whether such forest produce is grown or found on land owned by private persons or on land owned by the State Government or in Government forests :

Provided that rescission of such contracts and grants shall not affect the customary rights, if any, of the local Tribals to gather and collect the specified forest produce.”

Repeal and
savings.

3. (1) The Orissa Forest Produce (Control of Trade) Amendment Ordinance, 1989 is hereby repealed. Orissa Ord-
inance No. 1
of 1989.

(2) Notwithstanding such repeal anything done, any action taken under the principal Act as amended by the said Ordinance shall be deemed to have been done or taken under the principal Act as amended by this Act.
