**THE ORISSA TENANTS' RELIEF (AMENDMENT)
ACT, 1958**

October 1958, first published in an extraordi-
nary issue of the Orissa Gazette, dated
the 5th October 1958*]

AN ACT TO AMEND THE ORISSA TENANTS' RELIEF
ACT, 1955.

WHEREAS it is expedient to amend the Orissa
Tenants' Relief Act, 1955 in the manner Orissa Act 5
of 1955.
hereinafter appearing ;

It is hereby enacted by the Legislature of the State
of Orissa in the Ninth Year of the Republic of India
as follows :

Short title
and commen-
cement.

1. (1) This act may be called the Orissa Tenants'
Relief (Amendment) Act, 1958.

(2) It shall come into force at once.

Amendment
of section 1,

2. In sub-section (4) of section 1 of the Orissa
Tenants' Relief Act, 1955 for the word ' , letters and Orissa Act 5
of 1955.
figures "30th day of June, 1958" the words, letters
and figures "30th day of June, 1959" shall be substi-
tuted.

Repeal and
savings.

3. (1) The Orissa Tenants' Relief (Amendment) Orissa Ord-
inance No. 4
of 1958.
Ordinance, 1958 is hereby repealed.

(2) Notwithstanding such repeal anything
done or any action taken in exercise of any power
conferred by or under the said Ordinance shall be
deemed to have been done or taken in exercise of the
powers conferred by or under this Act as if this Act
was in force on the day on which such thing was
done or action was taken.
