### ORDINANCE

### FURTHER TO AMEND THE ODISHA OFFICES OF PROFIT (REMOVAL OF DISQUALIFICATIONS) ACT, 1961

WHEREAS the Legislative Assembly of the State of Odisha is not in session;

AND WHEREAS, the Governor of Odisha is satisfied that circumstances exist which render it necessary for him to take immediate action to amend the Odisha Offices of Profit (Removal of Disqualifications) Act, 1961 in the manner hereinafter appearing;

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of Article 213 of the Constitution of India, the Governor of Odisha is pleased to make and promulgate the following Ordinance in the Sixty-sixth Year of the Republic of India :—

- Short title. 1. This Ordinance may be called the Odisha Offices of Profit (Removal of Disqualifications) Amendment Ordinance, 2016.

Amendment  
of Section 3.

2. In the Odisha Offices of Profit (Removal of Disqualifications) Act, 1961 (hereinafter referred to as the principal Act), in the Section 3, after clause (j), the following clause shall be inserted, namely:—

Odisha Act 26  
of 1961.

“(k) the office of Chairperson, Vice-Chairperson or Member, by whatever name called, in any statutory or non-statutory body specified in the Table.”

Insertion of  
new Table.

3. After the Schedule to the principal Act, the following table shall be inserted, namely:—
